Three Peaks Primary Academy joined Creative Education Trust in December 2014 and the CET Academy Council was formed, this is a subcommittee of Creative Education Trust. The Academy Council (AC) members are nominated by the academy or AC and appointed by the Trust. The Principal's role is Ex Officio.

A maximum term of office is three years and Trust appointments may be one, two or three years with subsequent reappointments by mutual agreement. In line with the Trusts scheme of delegation, maximum service is nine years.
